2. TENDER RFT2014/019 SUPPLY OF ELECTRICITY TO LARGE & SMALL SITES

RECOMMENDATION: That Council:

 Award Origin Energy Electricity Ltd the contract for the supply of electricity to Riverina Water's large and small sites for an estimated price of \$757,703 (this cost does not include associated network charges)

Tenders for the supply of electricity for small sites, large sites, street lighting and high voltage sites were called by WWCC on behalf of Riverina Water County Council, Goldenfields Water County Council and Wagga Wagga City Council. Tenderers were invited to submit fixed prices for a 12 month period ending 30 June 2015. The contract has 2 x 12 month contract extensions that may be utilised at the discretion of each Council.

Please note that this tender is for supply of energy and does not include electricity network charges.

Tenders closed Monday 26 May 2014 and three offers were received.

The submissions were assessed by a tender evaluation panel consisting of:

The tenders were assessed using the criteria contained in the tender documents, being:

- Price
- Quality / Experience
- Performance Record

The following general convention was used to assign scores against each element of the evaluation criteria. Assignment of scores within ranges was at the discretion of the panel and allocated on an averaged basis against the predetermined weightings.



Cost changes over previous rates using the same historical annual usage dataset was estimated to be \$868,934 which is an estimated cost saving of \$111,231.


