QUESTIONS AND STATEMENTS

10/129 Clr. Yates: Queried the level of water in aquifers since the flood, realised its early days but asked how are they fairing? Could be benefits from flooding. Knowledge of what has happened to alleviate fears of customers regarding supply security? Director of Engineering. Will request monitoring data from NSW Office of Water regarding aquifer levels, but it may be months before levels rise. 10/130 Clr. Kreutzberger: Requested information on the progress on the farm drought security investigations. <u>Director of Engineering</u>: Have had discussions between our consultants who are developing a 30 year plan for the rural scheme. One option will include the farm proposal promoted by Urana and Greater Hume Shire Councils. 10/131 Clr. Kreutzberger: Requested information on the status of the bore source near Morgans Lookout for Walla Walla? Director of Engineering: Reported that the recent consultation for the Billabong groundwater water sharing plan had established that this bore is not available for town water supply as it is used for environmental purposes. 10/132 Clr. Vidler: Has Minister Costa advised if we will get answer on NSW Water Reform before next State Election in March 2011. Chairperson: Still promised outcome, but no date as yet. General Manager: Before Christmas. 10/133 Chairperson: Would like to thank Clr McInerney for his tenure and support as Vice Chairperson for last 2 years. Clr. McInerney: Total pleasure. 10/134 Next meeting will be Friday, 10th December, 2010, to be followed by Council's Staff Christmas Gathering.
