<u>Director of Engineering</u>: Pressure testing has been undertaken on the Henty to Morven water main.

<u>CIr. Meyer OAM</u>: Issue with farmers, can't get water east of Culcairn (Weston).

<u>Director of Engineering</u>: Check flow, data analysis, if ongoing issue please advise property owner to email us.

18/96 <u>Chairperson:</u> Water pressure issues at Yerong Creek and Henty, have they been measured?

<u>Director of Engineering</u>: Pressure varies 40 - 50, that pressure well within or level of service. Problem found at Kabota property downstream of the meter, not viable to increase pressure in main.

Internal issue for owner – number of stock troughs off line resulting in negative pressure at tank.

We've advised him on how he can improve his water supply. Formal letter to be sent following Council Meeting.

Clr. Bourke: Queried height of tank etc?

<u>Director of Engineering</u>: Height of internal tank greater than static head pressure in the main.

<u>Clr. Funnell</u>: - Property owner trying to avoid electricity costs.

<u>Director of Engineering</u>: Our responsibility finishes at meter, where there is a minimum 40m static head pressure.

Clr. Bourke: Queried if a ring main would fix his problem?

<u>Director of Engineering</u>: Ring main not practical in this case, extra 5m head in peak time.

<u>Clr. Meyer OAM</u>: - Is a pump on the main a solution?

<u>Director of Engineering</u>: No, tank on boundary, maybe a solution for property owner.

Director of Engineering: Flights to be organised.
